1. The *Ministry of Works and Transport* has allocated funds during the FY 2021/2022 for **Supply, Delivery and Installation of ICT Equipment for the National Building Review Board.**
2. The Ministry of Works and Transport invites sealed bids for the provision of the above supplies.
3. Bidding will be conducted in accordance with the open Domestic bidding method contained in the Public Procurement and Disposal of Public Assets Act, 2003, and is open to all bidders
4. Interested eligible bidders may obtain further information and inspect the bidding documents at the address given below at 8(a) from 9.00Am to 3.00PM
5. Bidding documents in English may be purchased by interested bidders on submission of a written application to the address below at 8 (b), upon payment of a non-refundable fee of **UGX: 100,000 (One Hundred Thousand Uganda Shillings only)**, The method of payment will be through Banks authorised to receive non-taxable revenues. On presentation of proof of payment, bidding documents may then be collected from the address at 8 (c).
6. Bids must be delivered to the address below in 8 (c) on or before **6th September 2021, 10:30a.m.** All bids must be accompanied by a bid security of: **Ugx 11,000,000 for lot 1, Ugx 1,800,000 for lot 2, Ugx 3,700,000 for lot 4 and Ugx 2,500,000 for lot 4.** Bid securities must be valid until **4th January 2022.** Late bids shall be rejected. Bids will be opened immediately thereafter in the presence of the bidders' representatives who choose to attend in the Board Room at the address below at 8 (a) at 11:00a.m.
7. There shall not be a pre – bid meeting/ site visit.
